# **Live Stream**

### 1. Register

#### To join the 2020 Annual Meeting of

**Shareholders** webinar, you must register to live stream the event on your computer, tablet or smartphone. You can do this ahead of time or right before joining.

• Visit the registration link below to open the registration page.

#### tinyurl.com/kuukpikcorp

• Enter your contact information and fill out any other required fields, then click **REGISTER**.

Once you've successfully registered, you'll see a confirmation page.

### 2. Join Webinar

Once you've registered, you will receive a confirmation email that includes information on how to join the meeting. When the annual meeting webinar is about to begin, you can use that information to gain access. You may be prompted to download and install the GoToWebinar application. (If on a smart phone or tablet, you will be prompted to download the GoToWebinar app. The application is free to use.)

# When it's time, you can join in either of the following ways:

- Join link Click the JOIN WEBINAR button in your confirmation email to be instantly launched into a session in the GoToWebinar application.
- Webinar ID If you don't have your join link, go to *www.gotomeeting.com/webinar/joinwebinar* and enter your email address and the following 9-digit webinar ID:

#### 3. Set up Audio

Once you've been launched into the Annual Meeting session, you will be prompted to set up your audio.

# To use your computer's microphone and speakers:

- Click COMPUTER AUDIO.
- Use the drop-down menus to select the desired audio devices.
- Click **CONTINUE**.

#### To use your telephone for audio:

- Click PHONE CALL.
- Dial the phone number as shown in your confirmation email and enter the codes when prompted.
- Click CONTINUE.

### 4. Watch Annual Meeting

Once you've finished setting up. your audio, you're all set! Depending on whether the webinar has started yet, you'll see one of the following:

- If you see the message "The meeting will begin when the organizer arrives," then the meeting has not yet started broadcasting. You'll be able to hear the audio once the broadcast begins.
- If you see a new window open with the message "Waiting to view **2020 Annual Meeting of Shareholders** screen," then the webinar has officially begun and any visual content should appear shortly. You should be able to hear the audio at this point.

# **Audio ONLY**

If you prefer to dial in for an **audio-only meeting**, no registration is required.

# Option 2: Online

As an alternative to mailing in a paper proxy ballot, you have the option to cast your proxy votes online. Online proxy voting is fast, convenient, and confidential. If you have questions about the online voting process or need additional information, please contact Josie Leavitt or Kimberly Gregory. Your online proxy must be submitted no later than **noon Alaska Time, Saturday, June 20, 2020**.

## STEP 1: Login



Visit *kuukpikvote.com* using your favorite web browser. At the login page, enter your confidential PIN (printed with your voter information at the top right of your proxy ballot, in your mailed proxy packet), along with the last 4 digits of your social security number\*. Then click the **LOGIN** button.

\*Custodians should use the last four digits of their own social security number. Non-shareholder custodians should use the last four-digits of their oldest minor's social security number.

## **STEP 2: Election of Directors**




After logging in, The number of director votes that you are entitled to cast appears in the upper right corner. You may cast all of your votes for one nominee or divide your votes among the nominees as you see fit. You may also cast all or a portion of your votes to a write-in nominee. To distribute your available votes equally among certain nominees, check the box next to the desired nominees and click the **DISTRIBUTE VOTES** button. If you do not cast any votes for nominees, your votes will be allocated to the Management Slate Nominees, at the discretion of the proxy holders. When you are finished, click the **NEXT** button.

### **STEP 3: Confirmation & Proxy Appointment**



Review your vote choices here. If your votes are correct, click the **VOTE** button to officially submit your proxy. To get an email copy of your proxy, enter your email address in the box at the bottom of the page. To make changes to your vote selections, click **START OVER.** 

### STEP 4: Thank you



This page indicates that your proxy votes were successfully received by the Inspector of Election and ends the web proxy voting process. If you want to change your votes on your proxy later, you can revisit the website and vote again until the deadline. Only your latest submitted proxy will be counted.
